5.1 LONG TERM PLAN 2024-2034 HEARINGS

PURPOSE

The purpose of this report is to provide Council with the submissions on the 2024-34 Long Term Plan consultation ahead of the hearings for those submitters who wished to present their submissions orally.

Hearings will take place on Wednesday 22 May (9.00am – 12.10pm and 6.00pm – 7.25pm); Thursday 23 May (9am – 5.25pm) and Friday 24 May (9.00am – 1.10pm) at Waiata House, Lincoln Road, Masterton. Hearings will also be livestreamed via the Council's You Tube channel.

This report also provides Council with the submissions received on the Rates Remission and Postponement on Māori Freehold Land Policy.

RECOMMENDATIONS

That Council

- i. **Receives** submissions on the 2024-34 Long Term Plan consultation that were submitted by the 89 submitters that have requested to be heard by Council.
- ii. **Agrees** to accept two additional submissions from Recreation Aotearoa and Age Concern that were received after 6 May 2024 that also wish to be heard.
- iii. **Notes** that a total of 837 submissions, including the two late submissions, were received; that the remainder of submissions received will be published on the Council website as soon as the processing of these has been completed; and that these submissions will be formally received at the deliberations meeting on Wednesday 5 June 2024.
- iv. **Receives** the five submissions on the Rates Remission and Postponement on Māori Freehold Land Policy.
- v. **Notes** no submitters requested to be heard by Council in relation to the Rates Remission and postponement on Māori Freehold Land Policy.

CONTEXT

Council adopted the options for consultation at the Council meeting held on 6 March 2024, and adopted the 2024-34 Long Term Plan Consultation Document on 3 April 2024. Links to these agendas are included below:

Council also adopted the statement of proposal for the Remission and Postponement of Rates on Māori Freehold Land Policy (the Policy) at the same time ([3 April Council Agenda](#) pages 130-136). No submitters have indicated they wish to be heard in relation to that Policy.

Section 93 of the Local Government Act (LGA) 2002 requires Council to use the Special Consultative Procedure as outlined in Section 83 when adopting a Long-Term Plan. Consultation must also meet the principles of consultation as specified in Section 82.

Section 108 of the LGA also requires a policy on remission and postponement of rates on Māori Freehold Land to be reviewed using a consultation process that gives effect to the requirements of section 82.

Both Section 82 and Section 83 require Council to provide opportunities for people to present their views. A formal Hearings process is one way of enabling that.

ANALYSIS AND ADVICE

Consultation Process

Consultation launched on Friday 5 April and closed at 10am on Monday 6 May 2024.

The Long-Term Plan Consultation Document and Submission Form were available on our website, from the Customer Service Centre (161 Queen Street) and the Library.

The opportunity to submit was widely advertised to our community via direct emails to key stakeholders and community groups, through social media, Google Ads, You Tube, Wairarapa Midweek, local radio and television.

Elected members and staff also hosted or attended a range of ‘pop-ups’ and community meetings to raise awareness of the opportunity to have a say and to respond to questions regarding consultation topics.

The Mayor was available through regular community “Mayor in the Chair” drop-ins on Thursdays at the Queen Street Customer Service Centre, and one in the Town Square, during the consultation process.

Submissions on the Long-Term Plan

To provide some administrative flexibility, all submissions received on 6 May (including those received after 10am) have been accepted. A total of 837 submissions were received.

In addition, two submissions were received after that date, and are therefore considered late submissions. Council can resolve to include these submissions, or not.

Given the volume of submissions received, submissions for those who want to be heard have been processed first. The balance of submissions will be released and published on the Council website as soon as processing is completed. These submissions will be formally received at the deliberations meeting on Wednesday 5 June 2024.

Submissions received on the Rates Remission and Postponement of Rates on Māori Freehold Land Policy

Five submissions were received on the Rates Remission and Postponement on Māori Freehold Land Policy. These submissions are provided in Attachment 1 to this report.

Council will be asked to consider the submissions received and adopt the final Policy at the deliberations meeting on Wednesday 5 June 2024.

Hearings

The hearings procedure is attached for reference as Attachment 2. Submitters will be heard in person and via Microsoft Teams. Submitters' discussion should remain on the specified submission that they are speaking to.

The hearings schedule is attached as Attachment 3.

Deliberations

Analysis of the submissions and trends will be presented to Council as part of the Deliberations reports. These reports will include advice from staff regarding the submissions received.

Council will discuss the submissions received, submission analysis and proposed recommendations; consider the views of the community and advice from staff and advisory groups; and make decisions at the deliberations meeting scheduled for Wednesday 5 June 2024.

RECOMMENDED OPTION

The 2024-34 Long Term Plan will be submitted to Council for adoption at the 26 June 2024 Council meeting.

Council will be asked to consider adopting the Rates Remission and Postponement on Māori Freehold Land Policy at the deliberations meeting on 5 June.

SUMMARY OF CONSIDERATIONS

Strategic, Policy and Legislative Implications

Section 82 of the Local Government Act 2002 (LGA) sets our principles of consultation which must be met when undertaking consultation.

Section 93 of the Local Government Act (LGA) requires use of the Special Consultation Procedure as specified in Section 83 of the Act for Long Term Plan. This includes preparing and adopting a consultation document, or statement of proposal, and encouraging people to present their views.

Significance, Engagement and Consultation

Consultation using the Special Consultative Procedure was undertaken from 5 April 2024 to 6 May 2024 to inform the 2024-34 Long Term Plan and seek community feedback on the Policy.

Financial Considerations

There are no specific financial considerations associated with the receipt or hearing of submissions.

Implications for Māori

21.3% of people in the Masterton District identify as Māori (Census 2018). There are no specific implications for Māori arising from the receipt or hearing of submissions. Analysis of submitter demographics will be included in the deliberations report.

The Hearings process and opportunity to be heard was promoted in the Consultation Document.

Māori freehold land makes up 5% of New Zealand. This land has strong cultural value. Many whanau dream to live on this land as their ancestors did but there are many barriers to development of Māori freehold land. Implementing the preferred option to adopt this policy would address one of the barriers to develop papakainga. More housing opportunities, particularly for whanau to live on their whenua would provide benefits not just for them but the wider community (through participating in the local economy). It could enable people to move home and strengthen intergenerational connections within whanau.
