BUILDING CONTROL SERVICES ACTIVITY

Activity Levels, Staff and Service

Activity for the year to date is similar to last year.

Building Consent Authority Accreditation

During the month of November International Accreditation New Zealand are auditing Councils Building Consent Authority functions. IANZ identified 13 General non-compliances, one of which we resolved on site.

Most of the issues identified are procedural and minor administrative issues:


- MDC did not have a list of inspections, nor a description for each inspection
- MDC's advisory of the MBIE levy had not been updated
- Compliance Schedules need more technical detail
- Contractors were not listed on the MDC skill matrix
- Competency assessments were missing some minor details
- Training Plans were incomplete (reviewing, setting deadlines, and applications of training received)
- No documented procedure for engaging contractors
- Calibration of thermometers did not include variance of reference thermometer




- 5 technical audits not completed
- Induction procedure did not explain how new staff would be inducted to the Council Building Accreditation manual.

Building Consent Authority Statistics


The number of applications received remains relatively consistent with last year




The number of applications issued is the same as last year.










The number of Code Compliance Certificates issued remains steady

Building Warrants of Fitness (BWoF)

Annual BWoF renewals provided to Council are all being reviewed within 20-working days.



Swimming Pools

194 Pool inspections have been undertaken to 175 pools. Sixteen Notices to Fix have been issued to owners of non-compliant pools.

There are 8 pools requiring inspection that are not accessible to staff. Letters have been sent out to the homeowners requesting they contact the building team to book a suitable time for the inspection.
