Interim decision of Hearing Panel

 - A discretionary activity rule for subdivision of the Site; and
 - No structure plan; and
 - An Outline Development Plan that is enhanced and improved to make it clearer.
- 4. This interim decision is subject to two provisos, as follows:
 - a. That the Hearing Panel is satisfied and comfortable with the revised provisions put forward by Welhom; and
 - b. That the Hearing Panel needs to revisit the NPS-HPL matters in light of the Environment Court decision on Balmoral Developments Ltd & Others v Dunedin City Council (EnvC 59).

- 5. Welhom are to provide the following information by <u>close of business on Wednesday</u> 3 May 2023:
 - A restricted discretionary activity rule for land use consent for a retirement village on the Site that includes a clause requiring notification of Waka Kotahi; and
 - A discretionary activity rule for subdivision of the Site; and
 - An Outline Development Plan that is enhanced and improved to make it clearer.
- 6. Council and Waka Kotahi are to provide comments on the information submitted in response to point 5 above by close of business on Monday 8 May.
