Call for lead architecture tenders for library and Waiata House extensions

Masterton District Council is moving forward with key projects decided as part of the 2024-34 Long-Term Plan, and has called for tenders for lead architects for the refurbishment and extension of Masterton District Library, and extension of its Waiata House offices.

As part of its 2024-34 Long-Term Plan, the Council decided to extend and refurbish the library, creating a modern library space with room for programmes. community events, and activities, including a creative classroom, work room, and open space office.

The budget is \$10.75 million spread over three years.

The Council also decided to extend its Waiata House offices to accommodate a purpose-built civil defence facility, customer services staff, public meeting rooms, and a laboratory for use by environmental services staff.

The budget is \$8.7 million.

Tenders must be lodged through NZ Government Tenders Service website (GETS)

The deadline for the library request for tenders (RFT) is 5pm on 24 July 2024. The deadline for the Waiata House RFT is 1pm on 9 August 2024.

The Council's General Manager - Infrastructure and Assets, Maseina Koneferenisi, said both projects were key for the community.

"We want to create spaces that that the community can be proud of. These projects provide an

opportunity to achieve our goals and aspirations for the town - bringing Masterton into the 21st century so it is a home that our tamariki and mokopuna can be proud of.

"Our vision is to create future-proofed spaces and places for our community, while also incorporating our history."

The Council is also moving ahead with plans to demolish the existing Town Hall and Municipal Buildings, including the façade, and build a new multi-purpose Town Hall on the current site, with a total budget of no more than \$25 million.


Under the District Plan, the building has local heritage significant but does not have a national heritage significance listing. Demolition is a 'discretionary activity' which means that it requires a Resource Consent under the Wairarapa Combined District Plan

A consultant planner has been appointed to assess and lodge the application on behalf of the Council, and a heritage architect engaged to prepare a report on the heritage value of the building to determine whether there are heritage values to consider.

The processing of this application will be undertaken by an independent consultant who will also make a recommendation to the Council on whether this is publicly notified.

Masterton District Council has confirmed its Long-Term Plan (LTP) for 2024-34 and with it an average rate rise for 2024/25 of 9.6 per cent.

This is 1 per cent less than forecast, after decisions by the Council during deliberations on the LTP consultation, at a meeting on 5 June and more growth in the rating base.

Because growth in the rating base - the number and value of properties sharing the cost of rates - has been stronger in the urban area, the urban rate increase will average 8.6 per cent, with variations due to property revaluations.

Rural properties will have an average 12.4 per cent increase, with variations between different types of property and revaluations. Higher rural rates are a result of roading costs increasing, and rural

properties being allocated a greater share of those costs (as set out in the Council's Revenue and Financing Policy).

Applications for rates rebates now open

Masterton District Council is now taking appointments for rates rebate applications for the 2024 to 2025 financial year.

Anyone who received a rates rebate last year, and wishes to apply again should call the council for an appointment on 06 370 6300.

If you haven't received a rates rebate before, and are on a low income, you may qualify for a full or partial rebate
